

## **LIBERTY SCHOOL-PARENT COMPACT**

**Liberty School** and the parents of the students participating in activities, services, and programs funded by Title I, Part A of the Elementary and Secondary Education Act (ESEA) (participating children), agree that this compact outlines how the parents, the entire school staff, and the students will share the responsibility for improved student academic achievement and the means by which the school and parents will build and develop a partnership that will help children achieve the State's high standards.

This school-parent compact is in effect during the 2014-15 school year.

## School Responsibilities

### Liberty School will:

- 1. Provide high-quality curriculum and instruction in a supportive and effective learning environment that enables the participating children to meet the State's student academic achievement standards as follows:**

*Students will use current materials and programs that support the Common Core State Standards as well as the NJ Core Curriculum Content Standards. Students and staff will use technology in developing and implementing lessons, administering assessments, and gathering data to drive instruction. Liberty School community members will work together to create a climate and culture of positive support through building-wide initiatives that promote positive behavior.*

- 2. Hold parent-teacher conferences (at least annually in elementary schools) during which this compact will be discussed as it relates to the individual child's achievement:**

*Parent-teacher conferences are scheduled for November 19<sup>th</sup>-21<sup>st</sup>. Additional conferences can be held, if necessary at an agreed upon day and time.*

- 3. Provide parents with frequent reports on their children's progress:**

*Parents will receive report cards at the end of each trimester (December 9, March 18, and the last day of school). Parents will receive informal periodic updates on student progress throughout the school year via phone or email at teacher discretion. Parents may also check their student's progress daily on the Grade Portal.*

- 4. Provide parents reasonable access to staff:**

*Staff will be available for parents via phone and e-mail daily. Parents that reach out to staff should expect a response within 24 hours on weekdays or by the end of the next school day (weekends, holidays excluded). Staff will also be available at parent-teacher conferences. Should a meeting be requested, an appointment should be made at least 24 hours ahead of time.*

- 5. Provide parents opportunities to volunteer and participate in their child's class and to observe classroom activities, as follows:**

*Parents are welcome to volunteer at all school-wide functions, through PTO involvement, and at specific activities throughout the year. Parents will be notified of opportunities as they arise. Should a parent wish to sit-in to observe their child's class, they should contact the teacher, who will arrange for said observation with the main office.*

## **Parent Responsibilities**

**We, as parents, will support our children's learning in the following ways:**
