

GREAT MEADOWS REGIONAL BOARD OF EDUCATION
MINUTES OF Tuesday February 26, 2019

The regular meeting of the Great Meadows Regional Board of Education was held on Tuesday, February 26, 2019 at the Great Meadows Middle School Gymnasium, Independence Township. The meeting was called to order at 7:01 PM by Lori Prymak, President. A statement was read that adequate notice of the meeting had been given in accordance with the Open Public Meetings Act.
